1. Complaints to the Nursing Council of New Zealand:-
Ms Donley stressed the importance of making personal representation in those instances where complaints had been reported to the Nursing Council. She advised that if an Idemnity Policy is held then any travelling costs incurred may be retrieveable.
2. Mileage Claims:-
Ms Sawers was concerned that payment advice slips do not include separate amounts for maternity services and mileage. It was agreed that midwives are responsible for their own records.
