Study day - Those present agreed that it was a valuable day with excellent information being shared. Disappointment was expressed at low attendance. Protocols for Obstetric Management — B.Pelvin expressed concern that womens choice is being compromised by the protocol for at risk women. Meeting planned with Hospital managers 8th Sept.M. Duncan and B.Pelvin to attend. The College wishes to challenge the support management of the Health Services has given to this protocol. The role of management is not to support a particular mode of care (i.e. Medical vs Midwifery model of care). Management should be impartial and to be otherwise is contrdictory to the policy of supporting consumer choice.

Clarification is required that consultation does not mean handover eg.when progress proceeds to a normal delivery.

If meeting with managers is unsuccessful, consumer support will need to be enlisted.

A separate protocol for midwifery is appropriate. The Health Dept Discussion Paper being the basis of this. The risk management form also rquires further discussion.
