GENERAL BUSINESS:

- 3) Birthday Cards have been designed by Kay Christiensen of East Auckland. to be sent to new mothers who have attended coffee groups. Interested local groups contact either Kate Jaunay (598-573) or Kay (598-654).
- 2) ISSUES NEEDING DISCUSSION AT CONFERENCE:
 - a) Name of Act: Nurses or Nurses & Midwives Act?
 - b) Increase in funding for Midwives will get same as doctors get now.
 - c) Changes in legislation; Health dept holding up change to legislation enabling midwives to prescribe drugs, direct referral to Labs etc.
 - d) Update on direct Entry Midwifery Training.
 - e) Midwives own confidence in themselves as independent practitioners.
 - f) Domiciliary midwives' contracts with Area Health Boards.
 - g) DMSRC update, difficulties in organising? needs new co-ordinator. Opposition from other parties? need for 2 non-homebirth consumers?
- 3) Home Help scheme being investigated by Diane McAllister. Pilot scheme for Central Auckland (Grey Lynn, Ponsonby, Mt Eden, Epsom, Mt albert, Mt Roskill), being area with highest # of Home births, around 200 per year Funding could start with COGS grant, applied for under the umbrella of AHBA, then go to Area Health Board and include early discharge mothers. Difficulties will be keeping worker(s) in full-time employment - could start with 2 part-time people; income tax; GST; funding for administrator could be hard to find (COGS not able to be used for that); getting mothers to use the service - by having it "As of Right", e.g. DMW's 3 antenatal visits, not as a sign of neediness or incompetence. Should be for 2-3 hours/day for a fortnight for primips, perhaps more, with childcare for multips.

Could co-ordinate with RESTART and AHB's.

- 4) MATERNITY SERVICES COMMITTEE report from Linda & Marjet: seems redundant to work being done by AK Women's Health Council.
- 5) NEWSLETTER needs more input, more help for Brenda. discussion of need for
- such a "swept-up" look, (Joan) but price charged will make people expect highest quality. Need more on collective. Kate to attend next meeting.

 6) Report by Shirley Tonkin, neonatal Paediatrician at St Helens states "higher incidence of cot deaths amongst home birth babies", her defini tion of home birth a any baby not born in hospital. Need to query her on this.
