Dear Lorna,

In April we received a grant to pay a co-ordinator and also to buy equipment. One of the items we intended to purchase was a Laser Printer. We now find that the printer that we require is going to cost \$5,200. We had been quoted \$2,500 when we made enquiries prior to making our application to you. But unfortunately this was the price of a model that wasn't suitable to cater for our requirements. We had also intended to purchase a Facsimile machine and received \$1,295 to cover the cost of it. Due to the increased cost of the laser printer we were hoping to use the money allocated for the facsimile to go towards paying for the printer and purchase a facsimile at a later date.
