The Delegates fees are the only compulsory payment but we would like to draw your attention to the following financial matters which are purely voluntary.

1. ROOM RENT COLLECTION It has been NCW practice to take up a collection at each meeting of approximately 20 cents per delegate, to help defray this cost. An increasing number of Affiliated Societies have chosen to save their delegates this small expense by making an annual donation. Ten meetings per year.

2. TRADING TABLE Most Societies take a turn in staffing the Bring and Buy Trading Table, this being the only means of financing your delegates expenses to the Bi-ennial Conferences. Sometimes two smaller Societies may combine, and although most make a special effort, the Societies are not expected to take full responsibility for stocking the table. Any small groups who would like to combine with another group, please let the Secretary know.

This too is a purely voluntary effort which avoids the possibility of Delegates to Conference being asked to pay all their own expenses. We would like to point out that, although fares are paid to and from Conference all delegates, including our President, pay all their own accomodation and meal expenses.

3. "CENTS IN MAY" Another voluntary donation.

Five cents per member of your Society per year, which is sent direct to National Office to help with the day by day running expenses of this establishment.
