THE RULES RULE O.K.

The Homebirth Movement has reached an important cross-road. We are faced with two very distinct and mutually exclusive directions.

The first option is that our Association be dissolved as an Incorporated Society (legally known as 'winding up') and that a totally new organisation be agreed to by concensus.

The other option is to persevere with our present Constitution (let us call it 'The Rules' as the word Constitution is off-putting). This would entail maintaining policy making and the National Body (President, Secretary and Treasurer) through the process of an AGM.

There can be no compromise on this issue— we have to choose one path or the other.

As hosts of next year's Conference and wishing to avoid the confusion and disappoint—

ment of the past we want this issue resolved.

There is much to commend the first option. Obviously, we need to concentrate our meagre resources at a local level. Homebirth conditions are so variable and each branch has greatly differing needs and problems. It should not surprise us then that some branches find supporting a National Body a burden and often irrelevant to their particular concerns.

We have had great difficulty dealing with 'The Rules'. Homebirthers tend to individualists -we instinctively shy away from authoritarian rules.

But, like it or not, we have a socialised Health system, largely controlled through a central government agency. Many of the issues of most importance to us are dictated by The State. For example, Midwives' pay, direct entry of foreign Midwives, and Health Dept. regulations. Inevitably, we are drawn into the business of seeking the ear of Government as various matters arise. This must entail some kind of National representation, acting on National policy. For this to be done fairly there must be a mechanism of clearly defined rules. Ultimately, we would have to work back to a set of rules such as we already have.

It is this branch's view that 'The Rules' can fulfill our needs. We see the problems of previous AGMs resulting from the fact that 'The Rules' were not clearly
presented, understood or implemented. Inevitably the result was chaos. We intend to
circulate a simplified set of 'The Rules' to all participants well in advance of the
AGM. In essence they are quite simple. Everybody would then be absolutely crystal
clear of their rights and responsibilities. The speaking and voting rights would be
enforced by an experienced chairperson. Under these circumstances the business of the
Association can be concluded swifty and fairly.

The AGM is small but vital thread that draws us together.

It is important to realize that 'The Rules' are adaptable. I quote from Rule IO
"These rules shall not be altered, added to or rescinded except by a resolution pass—
ed at an AGM by two-thirds of the members present and entitled to vote, notice of
the proposed alteration having been given in the Notice of the Meeting." In other
words 'The Rules' can be shaped to our particular needs providing it is done in the

prescribed manner.

N.B. This process has already begun, with several improvements made at the last AGM.

There is much of value in some of 'The Rules'. For example, the stipulation that the business of the Meeting be sent out with the Notice of the Meeting means that remits should be well discussed and thought out at the branch level before the vote is taken.

The 'faciliated congensus' idea may be fine for an 'ideas's ession but is not, in our view a suitable means for clear-cut decision making. To get the most out of those few hours together commonly shared rules are necessary. This is where we have come unstuck in the past.

We feel it would be premature to ditch 'The Rules' as they have yet to be properly implemented.

IN CONCLUSION: The present position is unsustainable. Either we go right back to the melting pot or use 'The Rules' in the way they were intended.

We have made our position clear. Which path do you choose?

We view this development as nothing more than the growing pains of a young and vigorous organisation.

Whatever the outcome we will be doing our best to provide for a damn good Confer ence next May. In whatever form we take we must be IOO% together in the cause of Home-birth. We must never lo se sight of that.
