National Committee and Restructuring of the College of Midwives

Ros Jaquiery and Sandra attended the National Committee meeting in Christchurch where a proposal was put forward that the College undergo a restructuring. Attached is the proposal and if you would like to make comment on this then Sandra would love to hear from you!!!


The objective of the proposed new structure is to function more effectively as a professional body and provide an improved service to the midwifery community. It is hoped that by having a Co-ordinator of Regions, which is a new position, that there will be a better link between regions and management. The Co-ordinator of Regions will liaise and network through out NZ, visiting every region at least once each year. It will be her job to trouble-shoot, co-ordinate MSRC and resolution committees nationally and arrange and hold workshops on regional requirements within each region. Should a region want/need more than one visit per annum this will be paid for by that region. The Co-ordinator of Regions who is based at head office is the person who services and supports the Regional co-ordinator (i.e. Sandra).

Proposed funding for the Co-ordinator of Regions position and the proposed restructuring will come from a reduction in the airfares to national committee meetings (regional co-ordinators will only attend the AGM) a transfer of funds from the MSRC, transfer of the National treasurers honorarium (as we now have a financial manager) and transfer of National committee expenses.

It will be discussed at the January College of Midwives meeting and in February too if necessary. As this is only a proposal at this stage it is important that you become involved and voice your criticism or support for this proposal in a constructive manner. Full details will be available at the next meeting including financial information.

After the meeting, Sandra and Ros were then joined by Penny Leadbeater for the Conflict Resolutions workshop which, as discussed in the last newsletter, is aiming to provide a nationally standardised set of guidelines to assist women and midwives achieve a more satisfactory outcome in the completion of their partnership.

Submission: Nurses Act Review

As discussed in a prior newsletter, moves are being made in the direction of establishing a Midwives Council in recognition of the separate nature of midwifery to nursing as opposed to the current status of midwifery being a branch of nursing.

At a recent one day workshop held by the NZCOM with representatives from both midwifery and nursing stake holders, it was the unanimous opinion of this meeting that there were no disadvantages to the public and many advantages to the midwifery profession to have its own legislation. It was also believed that a midwifery profession regulated by a body specifically required to do so would enhance professional standards and therefore public safety.

The content of this report is too in depth to summarise in this newsletter without losing important components so I have decided to leave things as they are and if you want to obtain a copy then contact either Sandra or myself and we will send one to you. Again, if you are interested in discussing this issue further the next COM meeting would be an appropriate venue and bear in mind that with all change comes a level of discomfort that eases with time.

ACC Classification of Midwives

ACC classification in premium risk groups has been reclassified to reflect the low risk of the midwifery profession. We now come under 86390 Health Services which includes occupational therapists, herbalists, podiatrists, homeopaths etc. This reclassification drops our ACC fee level from \$1.57 to \$1.22 and brings us in line with medicine.

Acupuncture Course for Midwives
